ARTICLES OF INCORPORATION
OF
THE SEVEN LIVELY ARTS ALLIANCE OF ST. JOHNS COUNTY, INC.

I, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617, Florida Statutes, do agree to the following:

ARTICLE I

The name of this corporation is THE SEVEN LIVELY ARTS ALLIANCE OF ST. JOHNS COUNTY, INC. The address of the principal office is 7175 A1A South, Unit A-207, St. Augustine, Florida 32086 and the mailing address of this corporation shall be 7175 A1A South, Unit A-207, St. Augustine, FL 32086 .

ARTICLE II

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida, is to provide a service organization to improve the arts and cultural climate of the St. Augustine community; to conduct workshops for art organizations; to provide the community at large with a calendar of events promoting the arts and related events; to seek donations of funds and grants to further such purposes; to make and receive contributions as and for organizations that qualify as exempt under Section 501(c)(3) of the Internal Revenue Code and any corresponding law of the State of Florida.

ARTICLE III

The membership of this corporation shall constitute all persons hereinafter named as officers and directors and other persons may become regular members upon election by either the members or the board of directors.

ARTICLE V

The corporation is to exist perpetually.

ARTICLE VI

The business of this corporation shall be managed by the Board of Directors. This corporation shall have four (4) directors initially. The number of directors may be increased or decreased from time to time by the By-Laws, but shall never be less than four (4).

The Board of Directors shall be appointed and hold office in accordance with the By-Laws.

The street address of the initial registered office of this corporation shall be 7175 A1A South, Unit A-207, St. Augustine, Florida 32086, and the name of the initial registered agent of the corporation at that address is JAN EARL JERTSON

ARTICLE VII

In accordance with Section 501(c)(3) of the Federal Internal Revenue Code, the corporation shall operate exclusively as a non-profit organization for the purposes set forth in Article II above. No part of the net earnings of the corporation shall inure to the benefit of any private shareholder or individual and no substantial part of the activities of the corporation shall be for carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in any political campaign on behalf of any candidate for public office.

No part of the earnings or assets of the Corporation shall inure to the benefit of its members, directors or officers or other private persons, except that of reasonable compensation for services rendered and to make payments in furtherance of the purposes set forth in the Certificate of Incorporation.

Further, upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the Corporation, dispose of the assets of the Corporation exclusively for the purposes of the Corporation in such manner, or to such organizations organized and operated for charitable, educational and such other pursuits similar to the Corporation as shall at the time qualify as an exempt organization under Section 501(c)(3) of the Internal Revenue Code as the Board of Directors shall determine. Any such assets not so disposed shall be disposed by the Court of jurisdiction, County of St. Johns, Florida, or whatever special provision as may be specified in the By-Laws of the Corporation under the same Code of the Internal Revenue Service, and none of the assets will be distributed to any member, officer or director of this corporation.

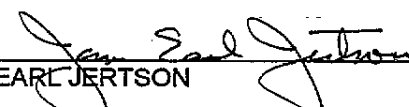
