ARTICLES OF INCORPORATION

OF

REACH, INC. A NONPROFIT CORPORATION

We, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I.

The name of the corporation shall be:

REACH, INC.

The address of the principal office of this corporation shall be 9279 Angora Street, Spring Hill, Florida 34608, and the mailing address of the corporation shall be the same.

ARTICLE II.

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida is: to raise educational awareness for children with handicaps; to better the education and protect the rights and interests of children and young adults with disabilities; to insure their rights to be productive citizens and secure their futures, and; to be a source of information and support for families.

ARTICLE III

The manner in which the directors are to be elected or appointed is as stated in the by-laws.
