ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I – NAME

The name of the Corporation shall be **Moratorium 2000, Inc.**

ARTICLE II – PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be 8306 S.W. Mills Drive, # 607, Miami, Florida 33183.

ARTICLE III – PURPOSE(S)

The specific purpose for which the Corporation is organized is the development and implementation of an educational and organizational campaign as part of an international effort to obtain passage of a United Nations resolution calling for a worldwide moratorium on capital punishment.

ARTICLE IV – MANNER OF ELECTION OR APPOINTMENT OF DIRECTORS

The Directors of the Corporation shall be appointed by the Executive Director.
