ARTICLES OF INCORPORATION

OF

FRIENDS OF GREECE CULTURAL PROGRESSIVE ORGANIZATION, INC.

ARTICLE I

NAME OF CORPORATION

The name of this organization shall be FRIENDS OF GRECE CULTURAL PROGRESSIVE ORGANIZATION, INC.

ARTICLE II

TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE III

GENERAL NATURE OF CORPORATION (PURPOSE)

- (A) This corporation shall be NOT FOR PROFIT. The purpose of this corporation shall be to promote, encourage and accelerate the knowledge, awareness and advancement of the Greek and Hellenic culture and education, and to establish and/or support Greek and Hellenic educational and cultural programs in the United States and abroad. Any and all purposes of this corporation shall be for purposes that qualify for exemption from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended or corresponding provisions of any future United States Internal Revenue Code and the regulations promulgated thereunder.
 - (B) This corporation shall not conduct or carry on any

activities prohibited from being conducted or carried on (a) by an organization exempt from Federal taxation under Section 501(c)(3) of the Internal Revenue Code and the regulations thereunder, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code and the regulations promulgated thereunder.

(C) Under the provisions of Section 501 and 4945 of the Internal Revenue Code, this corporation may not grant funds to be used to carry on propagands, to attempt to influence legislation, or to participate in, or intervene in or attempt to influence the outcome of political campaigns or elections.

ARTICLE IV

ARTICLE XII

TAX EXEMPT STATUS

(A) This organization is being organized with the intention of exemption from Federal Income Taxes, and shall file all necessary documentation with all government agencies to obtain and

maintain its tax exempt status. Upon its dissolution, it shall distribute its assets to an organization whose purpose is the same or similar to this organization.

- (B) Said organization is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- (C) No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501

(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

(D) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Circuit or County Court of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
