The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I--NAME**

**ARTICLE V--INITIAL REGISTERED AGENT AND STREET ADDRESS**




