


ARTICLE I

The name of this Corporation shall be INTERNATIONAL WORD OF TRUTH MINISTRIES, INC.

ARTICLE II

This corporation is incorporated under Chapter 617, Florida Statutes, as a Corporation Not for Profit.

ARTICLE III

This corporation shall exist in perpetuity.

ARTICLE IV

The street address of this Corporation shall, initially, be 1173 S. E. O'Donnell Lane, Port St. Lucie, FL 34983.

ARTICLE V

The purpose of this Corporation is to conduct ministries both within and without the State of Florida; to train lay persons, pastors, missionaries, evangelists, teachers and christian workers in the word of God and of missionary work and responsibilities; to establish schools for the education of children from pre-school to high school age, to include home school curriculum; to establish

training for the ordination of selected clergy; to conduct church services; to own, lease, sell and deal in real and personal property, but only for the purpose of effectuating the purposes set forth herein.

ARTICLE VI

The incorporator of the Corporation is LARRY HUNT, and the initial directors of the Corporation are LARRY HUNT, SHIRLEY HUNT and DUANE HARNEY whose addresses are as shown below. The method of electing directors shall be as stated in the By-Laws of the Corporation. The Corporation shall have three (3) directors initially, which may be increased or diminished from time to time by the By-Laws of the Corporation, but shall never be less than three (3) directors.

ARTICLE VII

The name of the registered agent of this Corporation shall be LARRY HUNT, whose street address is shown in Article IV, above.

By his signature below, such Registered Agent hereby affirms that he is aware of his duties as Registered Agent for said Corporation.

ARTICLE VIII

Provisions for the regulation of the internal affairs of the Corporation, including, but not limited to, any provisions with respect to the relative rights or interests of the members as among themselves or in the property of the Corporation, the manner of

termination of membership in the Corporation, the rights upon termination of membership in the Corporation, the terminated members and the remaining members, the transferability or non-transferability of membership in the Corporation, the distribution of assets upon dissolution or final liquidation, and classes of membership shall be stated in the By-Laws of the Corporation.

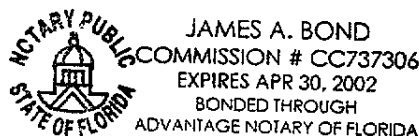
