ARTICLES OF INCORPORATION OF

IGLESIA CRISTIANA JOSUE, INC. A Florida Nonprofit Corporation

Article one Name

The name of this corporation is Iglesia Cristiana Josue, INC.

Article two Statement of Corporate Nature

This is a nonprofit corporation organized solely for general charitable purposes pursuant to the Florida Not For Profit Corporation Act.

Article three Purposes

The specific and primary purposes for which this corporation is formed are to operate for the advancement of religion and for other charitable purposes, by the distributions of its funds for such purposes and particularly for the observance of Christian religion.

The general purposes for which this corporation is formed are to operate exclusively for such religious purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions qualifying as tax exempt organizations under that Code.



This corporation shall not, as a substantial part of its activities, carry out propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

This corporation shall conduct local churches, acquire and hold real property,

spread the word of the gospel through seminars, radio, television, establishing church literature, establishing a Bible school training center, a school of theology, day care center, book store and other related matters. This corporation will be ordaining and licensing ministers to the gospel ministry of Jesus Christ. This corporation will be receiving and accepting gifts and contributions.

Article four Dedication of Assets

The property of this corporation is irrevocably dedicate to religious purposes and no part of the net income of assets of this corporation shall ever come into the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

Article five Membership

The corporation shall have a membership distinct from the officers. Any person agreeing to accept Jesus Christ as his savior, and to be bound by the articles of incorporation of this corporation, by its by laws, and by such rulers and regulations as the officers may from time to time adopt, is eligible for membership in the corporation. The officers shall from time to time prescribe the form and manner in which application may be made for membership.

Article six Location of Initial Registered Office and Name of Initials Registered Agent

The street address of the initial registered office of the corporation is 152 Rivera Circle, City of Weston, Broward, State of Florida, 33326.

Article seven Distributions of Assets

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a nonprofit fund, foundation, or corporation organized and operated exclusively for religious purposes which has established its tax exempt status under section 501(c) (3) of the Internal Revenue code of 1954, or corresponding provisions of any subsequent federal tax laws.

Article Eight Officers and Incorporators

Directors are to be elected by members of the church with the majority ruling. This election will be held the second week of November of each year.
