ARTICLES OF INCORPORATION OF FLORIDA SURGEONS FORUM, INC.

The undersigned, being a natural person of the age of more than twenty-one years, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a not for profit corporation pursuant to the provisions of the Florida Not for Profit Corporation Act.

FIRST: The name of the corporation ("Corporation") shall be the Florida Surgeons Forum, Inc.

The principal place of business of this corporation shall be 2589 Park Street, Jacksonville, Florida 32204.

SECOND: The duration of the corporation shall be perpetual.

THIRD: The purposes for which the Corporation is organized, which shall continue to be the purposes of the Corporation until and if the same be amended pursuant to the provisions of the Florida Not for Profit Corporation Act, and which shall include the authority of the Corporation to transact any lawful business for which a corporation may be incorporated under the Florida Not for Profit Corporation Act, are as follows:

- A. To promote the interests of surgeons and their patients throughout the State of Florida, through all forms of legislative and political action, including, but not limited to, contributions to political candidates.
- B. To have all of the powers conferred upon corporations organized under the Florida Not For Profit Corporation Act.

FOURTH: The address of the initial registered office of the Corporation in the State of Florida is 2589 Park Street, Jacksonville, County of Duval, Florida 32204; and the name of the initial registered agent of the Corporation at such address is Robert J. Harvey.

FIFTH: The standards for eligibility of members shall be contained in the Bylaws of the Corporation.

SIXTH: The manner in which the directors of the Corporation shall be elected shall be contained in the Bylaws of the Corporation.
