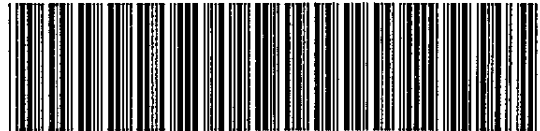



Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation.

Article 3-Purpose

The purposes for which the corporation is organized is: This is a non-stock, non-profit corporation. This corporation will engage in, but shall not be limited to the following activities: Housing counseling services, educational services, economic development, substance abuse services, at risk youth services, assessment services and HIV/AIDS outreach services. The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. Said corporation is organized exclusively for charitable, religious and educational purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3). Notwithstanding any other provision, the organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501c3 of the Internal Revenue Code of 1986. Or corresponding revision of any future United States Internal Revenue law.
