## ARTICLES OF INCORPORATION

The undersigned acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes adopt(s) the following of incorporation:

### ARTICLES 1

The name of the corporation shall be:

### ARTICLES 3

Purpose(s)

The specific purpose(s) for which this corporation is organized for which this corporation is exclusively for one or more of the purposes as specified in Section 501(c) (3 ) of the Internal Revenue Code including for charitable, educational, religious, and scientific purposes. The making of distributions to organization that qualify as exempt organization under Section 501(c) (3) of the Internal Revenue Service or corresponding section of any future Federal tax code.

Destiny Enterprises, Low Economic Development Center, Inc., was formed as a nonprofit community service organization. This program will assist with the economic development in the following areas: Low-income assistance programs for families, seniors, individuals, and youth. This organization will also target communities with high poverty levels and low economic development. It will set goals that will lead to improved living conditions through housing, education, job opportunities, and forming a network of businesses that will provide job opportunities.

This program will assist all people no matter what race, color, or national origin. However, in some situations certain groups will be targeted according to their specific needs. (1) Seniors who may need assistance with their living conditions and health issues. (2) Migrant workers who have seasonal and farm working backgrounds. (3) Youth (girls and boys) who are potential high-school dropouts and/or juvenile delinquents, and teenage mothers and their offspring. (4) Women who want to continue their education and have a low-income background. (5) Will assist disabled and handicapped individuals to lead a more productive life style.

There will be low-income housing assistance provided for qualified applicants as funding permits. Community Service Centers that will provide recreation for teens, tutoring services, language development, cultural arts programs, or funding assistance for new or existing businesses. There will be funding for start-up capital or expansion. In all, this program will encourage individuals to lead a more productive life style, and therefore put something back into their communities.

#### ARTICLES 4 Manner of Election of Directors

The manner in which the directors are elected or appointed is as follows; the election of all directors shall be by written ballot. All qualified persons must be an active member of this organization. Must obey organization rules and regulations. Must share the visions of the organization and the interest of all members. He/she must exhibit good public relation skills, and must be voted in unanimously by all other existing board members.

#### ARTICLE 5

The corporate powers of this corporation are provided in section 617.0302, Florida Statues, unless limited as follows:

#### ARTICLE 6

The duration of this corporation is perpetual.

#### ARTICLE 7

The classes, rights, privileges, qualifications, and obligations of members of this corporation are as follows, as stated in the By-laws of this corporation.

#### ARTICLE 8 Additional/Provisions

Upon the dissolution of this corporation, it's assets remaining after payment, or provisions for payment, of all debts, and liabilities of this corporation shall be distributed for one or more exemption purposes within the remaining of section 501 (c) (3) of the Internal Revenue Code or shall be distributed to the federal government, for a public purposes.

No substantial part of the activities of this corporation shall consist of carrying on proper gander, or otherwise attempting to influence legislation (except as otherwise provided by section 501(H) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements, or any political campaign on the behalf of, or in opposition of any candidate for public office).

Notwithstanding any other provision of these articles, this corporation shall not carry any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under section 501c(3) of the Internal Revenue Code, or (2) by a corporation contributions to which are deductible under section 170c(2) of the Internal Code.
