Articles of Incorporation

Article I

Name

The name of this corporation will be The WALK Foundation, Inc.

Article II

Principal Office

The principal place of business and mailing address of this corporation shall be The WALK Foundation, Inc., 1825 Aaron Road, Tallahassee, FL 32303.

Article III

Purpose(s)

The purpose of the WALK Foundation is to provide programs and services that increase the bond between children and their families. The purposes for which this corporation is organized are exclusively charitable, scientific, literary and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue law. Notwithstanding any other provisions of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from taxation pursuant to the Federal Income Tax Code under Section 501(c)(3) or the corresponding provision of any future United States Internal Revenue law.

Article IV

Manner of Election of Directors

The manner in which the directors are elected or appointed is through the identification, approval, and appointment by the Incorporator to these Articles of Incorporation, Ginny Grimsley, Ph.D., President, as stated in the by-laws.

Article V

Initial Registered Agent and Street Address
