

## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

#### OF

#### NUEVA ESCUELA ARGENTINA DE LA FLORIDA, INC.

Pursuant to the provision of Chapter 617, Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: The name of the corporation is:

### NUEVA ESCUELA ARGENTINA DE LA FLORIDA, INC.

**SECOND:** The following amendment(s) to the articles of incorporation was (were) adopted by the corporation:

#### Article III, Section 2, as follows:

THE SPECIFIC PURPOSE FOR WHICH THE CORPORATION IS ORGANIZED SHALL BE: COMMUNITY EDUCATION, AND, THAT THE "NUEVA ESCUELA ARGENTINA DE LA FLORIDA, INC.", ADHERES TO A POLICY OF NON-DISCRIMINATION IN EMPLOYMENT AND EDUCATIONAL PROGRAMS/ACTIVITIES AND STRIVES AFFIRMATIVELY TO PROVIDE EQUAL OPPORTUNITY FOR ALL AS REQUIRED BY: TITLE VI OF THE CIVIL RIGHTS ACT OF 1964-PROHIBITS DISCRIMINATION ON THE BASIS OF RACE, COLOR, RELIGION OR NATIONAL ORIGIN; AND TITLE VII OF THE CIVIL RIGHTS ACT OF 1964, AS AMENDED - PROHIBITS DISCRIMINATION IN EMPLOYMENT ON THE BASIS OF RACE, COLOR, RELIGION. GENDER, OR NATIONAL ORIGIN; AND TITLE IX OF THE EDUCATION AMENDMENTS OF 1972- PROHIBITS DISCRIMINATION ON THE BASIS OF GENDER; AND THE AGE DISCRIMINATION IN EMPLOYMENT ACT OF 1967 (ADEA), AS AMENDED - PROHIBITS DISCRIMINATION ON THE BASIS OF AGE WITH RESPECT TO INDIVIDUALS WHICH ARE AT LEAST 40; AND THE EQUAL PAY ACT OF 1963, AS AMENDED - PROHIBITS SEX DISCRIMINATION IN PAYMENT OF WAGES TO WOMEN AND MEN PERFORMING SUBSTANTIALLY EQUAL WORK IN THE SAME ESTABLISHMENT; AND SECTION 504 OF THE REHABILITATION ACT OF 1973 -PROHIBITS DISCRIMINATION AGAINST THE DISABLED; AND THE AMERICANS WITH DISABILITIES ACT OF 1993 (ADA) - PROHIBITS DISCRIMINATION AGAINST INDIVIDUALS WITH DISABILITIES IN EMPLOYMENT, PUBLIC SERVICE, PUBLIC ACCOMMODATIONS, AND TELECOMMUNICATIONS; AND THE FAMILY AND MEDICAL LEAVE ACT OF 1993 (FMLA) - REQUIRES COVERED EMPLOYEES TO PROVIDE UP TO 12 WEEKS OF UNPAID, JOB PROTECTED LEAVE TO ELIGIBLE EMPLOYEES FOR CERTAIN FAMILY AND MEDICAL REASONS; AND THE PREGNANCY DISCRIMINATION ACT OF 1978 - PROHIBITS DISCRIMINATION IN EMPLOYMENT ON THE BASIS OF PREGNANCY, CHILDBIRTH, OR RELATED MEDICAL CONDITIONS; AND THE FLORIDA EDUCATIONAL EQUITY ACT (FEEA)- PROHIBITS DISCRIMINATION ON THE BASIS OF GENDER, RACE, NATIONAL ORIGIN, MARITAL STATUS, OR HANDICAP

AGAINST A STUDENT OR EMPLOYEE: AND THE FLORIDA CIVIL RIGHTS ACT OF 1992 - SECURE'S FOR ALL INDIVIDUALS WITHIN THE STATE FREEDOM FROM DISCRIMINATION BECAUSE OF RACE. COLOR, RELIGION, SEX, NATIONAL ORIGIN, AGE, HANDICAP, OR MARITAL STATUS; AND SCHOOL BOARD RULES 6GX13-5D-1.10, 6GX13-4A-1.01, 6GX13-4A-1.32 - PROHIBIT HARASSMENT AND/OR DISCRIMINATION AGAINST A STUDENT OR EMPLOYEE ON THE BASIS OF RACE, GENDER, COLOR, RELIGION, ETHNIC OR NATIONAL ORIGIN, POLITICAL BELIEFS, MARITAL STATUS, AGE, SEXUAL ORIENTATION, SOCIAL AND FAMILY BACKGROUND, LINGUISTIC PREFERENCE, OR DISABILITY; AND THE FAMILY RIGHTS AND PRIVACY ACT - A FEDERAL AND STATE LAW -PROTECTS THE ACCURACY AND PRIVACY OF STUDENT **EDUCATIONAL** RECORDS. AND THAT PARENTS. LEGAL GUARDIANS, LAY PERSONS AND/OR AUTHORIZED ADVOCATES HAVE THE RIGHT UPON REQUEST TO INSPECT, RELEASE, OBTAIN COPIES, AND CHALLENGE INFORMATION CONTAINED WITHIN THE STUDENT'S EDUCATIONAL RECORDS.

**THIRD:** The amendment(s) was/were adopted by the Board of Directors on the 21<sup>st</sup> day of June, 2000.

FOURTH: There are no members or members entitled to vote on the amendment.
