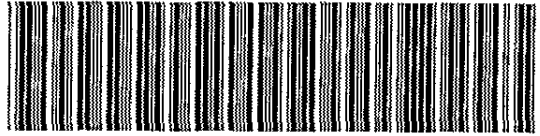

AMENDMENTS TO ARTICLES OF INCORPORATION

- 1 -

On Friday, September 29, the Board of Directors of the "ASOCIACION DE MINISTROS E IGLESIAS DE BROWARD (AMIB), INC. voted to make the following amendments to its Articles of Incorporation. These were adopted as follows:

Requirement No. 5 is added to Article IV of the Articles of Incorporation:

Membership Requirements for AMIB

This reads as follows:

5. To be an active member of the Association.

Article VIII of the Articles of Incorporation is changed as follows:

Quorum

At the opening of the Association's meetings, attendance verification of members will be conducted to establish the Quorum. To establish a Quorum half of the members plus one must be present. In case of having an odd number in the total of members attending, a Quorum will be established by rounding up the half to the next highest par number. (i.e. Total members: 33 - Quorum will be established with 17 members present at a meeting). The same applies for Administrative Board Meetings.

Changes are made to Assembly Rules "c" and "d" in Article III of the Regulatory Amendments of the Articles of Incorporation:

These rules are approved to read as follows:

- c. Every active member that is present at AMIB meetings at the moment that attendance has been passed will have right to speak and vote on issues under discussion. If for any reason a member is late for a meeting, he or she has to report immediately to the AMIB's Secretary in order to be included in the Quorum.
- d. A member is considered an "Active Member" if he or she has assisted to at least three consecutive or non-consecutive monthly meetings, and paid his/her annual membership.

Changes are made to the following item in Article IV of the Regulatory Amendments of the Articles of Incorporation that refers to Characteristics for Candidates:

Item that reads:

- Must have assisted to at least 6 meetings on the year of election

Changes to:

- Must have assisted to at least 4 meetings in his/her year of election.

AMENDMENTS TO ARTICLES OF INCORPORATION

- 2 -

The following additions are made to Article IV of the Regulatory Amendments of the Articles of Incorporation that refers to Characteristics for Candidates:

- To qualify for the President and Vice President position, all "Characteristics for Candidates" must be met. Additionally, a member must be the principal pastor of an established and known congregation.
- To qualify for the President and Vice President position, a member has to have assisted to at least 6 meetings during his/her election year as a member and paid his/her annual membership.

The following responsibility is added to Section A of Article V of the Regulatory Amendments of the Articles of Incorporation that refers to President's Responsibilities:

10. Must report monthly to the Secretary, received justified absences of the members to scheduled meetings.

The following responsibility is added to Section C of Article V of the Regulatory Amendments of the Articles of Incorporation that refers to Executive Secretary's Responsibilities:

4. To maintain records of members that have justified their absence to the Association's monthly meetings.
