## ADDENDUM

PURSUIT OF HAPPINESS, INC.

Article 7 - A program that is designed to treat and rehabilitate patients who have chronic disabilities such as arthritis, diabetes, hypertension, multiple sclerosis and other circulatory and degenerative conditions.

The main function is to rehabilitate and revitalize the patient through various therapeutically and non-evasive exercise techniques in conjunction with diet and nutrition.

Each system is specifically designed to treat each patient according to his or her disease and disability.

The program is designed around a specialty clinic is staffed and equipped with facilities equipment, professional therapist, nutritionists, trainers and assistants. By using these and working in conjunction with the primary care physician who would prescribe therapy, diet, along with exercise to treat each condition on an individual basis according to the disease and disability.

By equipping the specialty clinic with the proper facilities such as aqua-therapy, steam baths, whirlpools and other therapeutic equipment and using the trained therapists to guide the patient through a program designed specifically toward their rehabilitation.

Also included would be a restaurant staffed by professional nutritionists who would design a menu for each type of condition or disease. The facility would train the patient in proper nutritional and preparation needed for their treatment.
