Articles of Amendment Widows & Widowers Association.

Article III- Purpose

- a) The Widows & Widowers Association was organized with a purpose to serve as a support group for individuals who at some point in their lives experienced the doss of a loved one. The group is comprised of men and women with no preference to race religious affiliation or age group. These individuals meet each month, which gives them a chance to network together, which could be considered therapy for the distressed. Guests (i.e. community leaders, attorneys, medical professionals, etc.) are invited each month to speak at the monthly meetings. The topics are always focused on issue, which may be of assistance to the members. From livings wills/trusts to receiving proper medical assistance and home improvements.
- b) Members are asked to contribute \$5.00 per month as dues. However, no one is turned away or discriminated against if they cannot pay the fee. Letters are distributed to the area churches and businesses informing them of the association. Some of the churches, businesses and even individuals contribute various amounts to help in the cause of the association. None of the monies collected are now or in the future shall be distributed to any officer or other member of the association or private persons for anything other than compensation for reasonable services rendered to the association.

The dues collected are immediately deposited into a checking account by the president or treasurer. Monthly statements from the financial institution are received each month, and are available for reviewing at any time by an association member. The group has discussed the possibility of traveling to various places of interest (i.e. Atlanta to visit the King Center, Bucsh Gardens and Orlando) upon receiving enough money to help defray the cost of transportation and hotel accommodations.

The organization's goal is to recruit more members and begin networking with other such groups in hopes of becoming a nationally recognized organization.

The organization does not now nor in the future anticipate on becoming involved with any type of propaganda, political matters or publicly endorsing any political candidates.
