ARTICLE II - NATURE OF BUSINESS

The corporation is a Not For Profit Corporation.

- (a) The specific nature of the business or businesses to be transacted shall be:
 - 1. To establish and maintain a community resource center in Miami, Florida, and such other places within and outside of the state of Florida and such other places as may be appropriate for rendering services to Puerto Ricans and other minorities.
 - 2. To serve other charitable organizations qualified as tax-exempt under section 501(c)(3) of the Internal Revenue Code as a central source for information and a resource for needed management training, technical assistance, fund raising and support and other organizational needs.
 - To provide assistance to individuals who are unemployed, underemployed or in lower income bracket in identifying jobs, enhancing job search and interview skills; and will offer opportunities for occupational and professional development.
 - 4. To provide academic support, cultural and recreational programs for youth of lower income households. These programs will bring academic support (i.e. study skills, tutoring) to students; cultural programs will focus on increasing involvement and awareness of Puerto Rican heritage by developing community based cultural programs and working towards the inclusion of Puerto Rican culture and heritage in the public schools' curricula and programs.
 - 5. To house a community education center which will offer information, referral and assistance in public health, educational counseling, technical assistance to entrepreneurs and small businesses in order to foster economic growth and opportunities in the Puerto Rican Community; and, sponsor professional and leadership development workshops, seminars and conferences.
- (b) The general purpose for which this Corporation is formed is operate exclusively for such charitable purposes as will qualify it as a tax-exempt organization under section 501 (c) (3) of the Internal Revenue Code.
