ARTICLES OF INCORPORATION

GULF COAST AFRICAN AMERICAN CHAMBER OF COMMERCE, INC.

WE, the undersigned have associated ourselves as a body corporate with all the rights and privileges granted by the laws of the State of Florida and do hereby adopt Articles of Incorporation as follows:

ARTICLE ONE: The name of the corporation shall be Gulf Coast African American Chamber of Commerce, Inc., with its principal place of business at 2737 North "E" Street, Pensacola, FL 32501.

ARTICLE TWO:

Section 1. This Chamber of Commerce is organized for the purpose of advancing the economic, industrial, professional, cultural and civic welfare of the Gulf Coast, the Black Community; the promotion of the general welfare and prosperity of the city, county and surrounding territory; and the stimulation of public sentiment to these ends.

Section 2. This organization, in its activities, shall be non-profit, non-partisan, non-sectarian. It shall not, by resolution or otherwise, be committed to the support or endorsement of any candidate for public office.

ARTICLE THREE: The corporation may acquire, take by gift, purchase, devise or bequest real and personal property for purposes appropriate in the exercise of its powers, and may lease, mortgage and dispose of real and personal property including the right to take, hold and dispose of shares of stock in other corporations.

ARTICLE FOUR: This corporation will be perpetual in existence.

ARTICLE SEVEN: The Board of Directors shall adopt, amend, or repeal such Bylaws as they deem necessary for the regulation of the affairs of this corporation, the same shall apply to the proposal and adoption of amendments to the Articles.

ARTICLE EIGHT: The private property of the members of this corporation shall not be liable for the debts of this corporation but shall be wholly exempt therefrom.

ARTICLE NINE: The general nature, purposes and objectives of this corporation shall be to advance the economic, industrial, professional, cultural and civic welfare of the Gulf Coast, the Black Community. In the pursuit of these objectives, this corporation may do any and all things necessary for the success thereof, including the solicitation and acceptance of funds, cooperating with other corporations and organizations for the

attainment of these purposes including, but not 'limited to making distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1954, or the corresponding provision of any-future United States Internal Revenue Laws.




