Also attached is a copy of the letter forwarded to Ms. Katherine Harris, Secretary of State, on August 7, 2000. It was sent after we had a most difficult time attempting to speak to a live person to ask questions about the EIN, but without any success after ten telephone calls to State Department offices. We never received a response from Ms. Harris. Only seven of the ten times various departments were called did we get to speak to a human being. In both instances, however, neither could answer our questions.

It was only when I went to Tallahassee and visited three different State buildings was I able to have my question answered and pick up a form to apply for our EIN. I suggest that telephone numbers on your form be reviewed and changed as need dictates. That would make the form much more user-friendly.

1-850-488-9000 Called your department to ask what to do since no information was available for getting an FEI number. Was told if form is sent in without FEI number it would be returned. Asked what I can do. Referred to same numbers already called. Said it is not the State Department's job to issue FEI numbers. Said it has to be done by IRS.

1-800-829-3676 Called the first number again to ask for advice about what to do and who to call. Line continuously busy.

1-770-455-2361 Took IRS telephone number from my 1999 income tax booklet. Listened to recorded messages. None related to my need. Chose option to speak to a receptionist. Phone rang extensively, no one answered.

1-770-455-2361 After getting no one to speak to at these two numbers today, I did not know anything else to do but write for your assistance. It is easier and less frustrating to write than get a response by phone. The technology route is not people-friendly. It is nearly impossible to speak to a person.
