**Articles of Incorporation
of
El Grupo Ministerial Vision Cristiana, Inc.
(The Ministerial Group Christian Vision, Inc.)**

The undersigned, acting as the incorporators of a corporation pursuant to Chapter 617 of the Florida Statutes, the Florida Not For Profit Corporation Act, adopt the following Articles of Incorporation for such corporation:

Article 1

The name of the corporation is EL GRUPO MINISTERIAL VISION CRISTIANA, INC. (which means "The Ministerial Group Christian Vision, Inc." in English).

Article 2

The principle place of business and the mailing address of this corporation is 5903 North 47th Street, Tampa, Florida, 33610, Hillsborough County.

Article 3

- A. The corporation is organized exclusively for religious, charitable, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law), including, but not limited to, for such purposes, the establishing and maintaining of religious worship, the building, maintaining and operating of churches, parsonages, schools, chapels, radio stations, television stations, rescue missions, seminars, crusades, concerts, print shops, day-care centers, camps, and nursing homes.
- B. The corporation will ordain and license men to the Gospel Ministry; evangelize the unsaved by the proclaiming of the Gospel of the Lord Jesus Christ, educate believers in a manner consistent with the requirements of Holy Scripture both in churches and in schools of Christian education, maintain missionary activities in the United States and any foreign country, and any other lawful purpose or purposes not for pecuniary profit and not specifically prohibited to non-profit corporations under the laws of the state of Florida.

Article 4

The number of directors of the corporation shall be determined by resolution of the directors entitled to vote but shall not be less than three (3) directors. The method of election of directors shall be set forth in the bylaws of the corporation.

Article 5

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be

authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the tax-exempt purposes of the corporation set forth in Article 3.

Article 6

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, distribute all of the assets of the corporation to such organization or organizations organized and operated exclusively for charitable, religious, or educational purposes as shall at the time qualify as an organization exempt from Federal income taxation under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) as the Board of Directors shall determine.

Article 7

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Article 8

The corporation shall have a racially nondiscriminatory policy and therefore shall not discriminate on the basis of race, color, or national or ethnic origin.

Article 9

The street address of the initial registered office of the corporation is 4515 Riverfront Lane, #T-102, Tampa, Florida, 33603, and the name of the initial registered agent of the corporation at the initial registered office is E. Franklin Falero.

Article 11

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, except that the corporation shall not carry on any activities not permitted to be carried on by an

organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

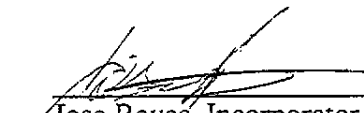
Article 12
