#### ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

- ~ To recruit a network of volunteers as mentors. From homemakers to men and women in the business and aviation community, to assist youths by guiding them throughout all phases of their life.
- ~ To bring a better understanding of aviation to the general public as well as accumulate and distribute information and materials to those students, teachers, parents and organizations expressing an interest in aviation. To foster and promote aviation activities to ignite an interest for the furtherance of education especially in math, science, and other subjects related to aviation/aerospace.
