**ARTICLE I
NAME**

DURATION**

The term of existence of the corporation is perpetual.

**ARTICLE III
PURPOSE**

The corporation is organized in order to engage in any lawful purpose or purposes not for pecuniary profit and more specifically for religious, charitable, literary or educational purposes which are consistent with running a church ministry provided there shall be no power to engage in any activity which would disqualify the corporation as an exempt organization which under §501 of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist or as they may hereafter be amended.

No part of the assets or the net earning of this corporation shall inure to the benefit of any private shareholder or individual;

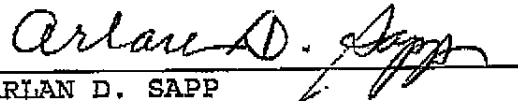
