

ARTICLE I-NAME

The name of the corporation shall be WORLD FAMILY LOVE MISSIONS, INC. (MUNDO FAMILIAR AMOR A LAS MISSIONES, INC.

ARTICLE II-DURATION

This corporation shall exist perpetually unless dissolved according to Florida Law.

ARTICLE III PURPOSE

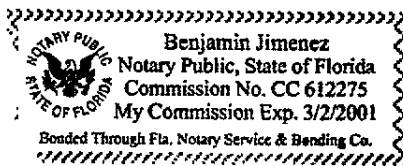



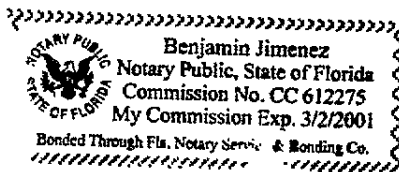
