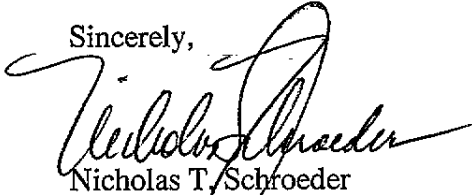

ARTICLES OF INCORPORATION
OF
MASS RELIEF FOR KOSOVO, YUGOSLAVIA, INC.

i, the undersigned incorporator, hereby make, subscribe, acknowledge and file with the Secretary of State of Florida, these Articles of Incorporation for the purpose of forming a corporation not for profit in accordance with the laws of the State of Florida, Chapter 617.

ARTICLE I

Name

The name of the corporation shall be MASS RELIEF FOR KOSOVO, YUGOSLAVIA, INC.

ARTICLE II

Purpose

The purpose of the corporation shall be to organize and provide charitable relief primarily for the people of Kosovo, Yugoslavia, who are displaced and afflicted by political and social oppression and war. The corporation shall also provide relief for the poor, the distressed, the elderly and the underprivileged of the world. Help shall be provided in all areas of need, food, medical assistance, transportation, housing, jobs, training, schooling, counseling, assistance in finding homes for orphans and facilities for the elderly.

The corporation is organized exclusively for charitable purposes and to function as a organization qualifying under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code and shall be limited in all aspects by the provisions of section 501(c)(3) and all regulations and rules established thereunder by the Internal Revenue Service, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under 501(c)(3) of the Internal Revenue Code.

ARTICLE III

Limitations

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV

Assets upon Dissolution

Upon the dissolution of the corporation assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue code, or the corresponding section of any future federal tax code; or shall be distributed to the federal government; or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.

ARTICLE V

ARTICLE VI

Existence of Corporation

This corporation shall have perpetual existence.

ARTICLE VII

Beginning of Corporate Existence

The date corporate existence shall begin shall be June 1, 1999.

ARTICLE VIII

Board of Directors

The business of this corporation shall be managed by its Board of Directors. The management of the business of the corporation shall be the responsibility of the Board of Directors, no officer or member of the corporation shall make any commitment in the name of the corporation without written authorized approval of the Board of Directors. Election of Directors shall be as specified in the By-Laws of the corporation.

ARTICLE IX

Directors

There shall be six (6) members of the Board of Directors of the Corporation. Initially there shall be four directors who will serve until the first election of directors as set forth in the By-Laws of the corporation. 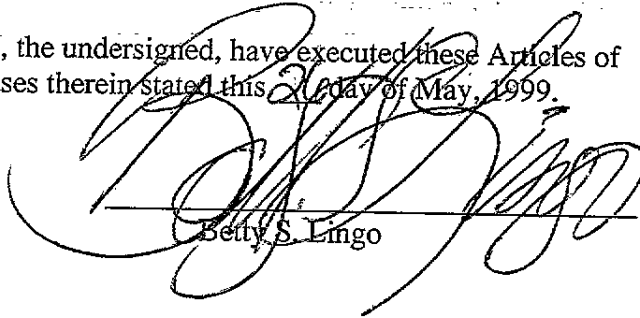

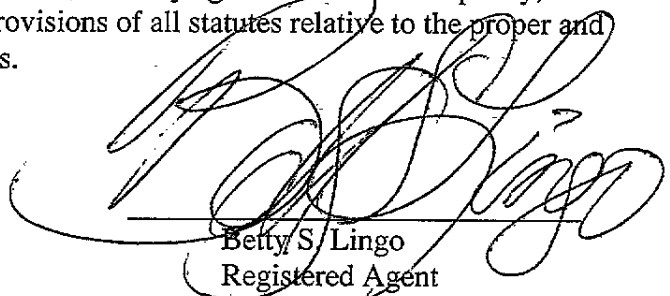
