

ARTICLES OF INCORPORATION

TRUE FAITH OUTREACH DEVELOPMENT, INC

SOUNT PARESO ONE: The name and address of this principal corporation is True Faith Outreac Development, Inc., 1630 N.W. 2nd Avenue, Pompano Beach, Florida 330607 This corporation is organized pursuant to FLORIDA Nonprofit Corporation Code.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.
