

- Said Corporation is organized exclusively for charitable, educational, religious ARTICLE or scientific purposes within the meaning of section 501(c)(3) of the Internal III Revenue Code of 1986.
- No part of the net earnings of the Corporation shall inure to the benefit of, ARTICLE IV or be distributable to, its members, trustees, directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in futherance of section 501(c)(3) purposes.
