Ladies and Gentlemen:

We represent the officers and directors of Plantation Christian University, Inc., a Florida nonprofit corporation formed July 22, 1996. The corporation's document number is N96000003859.

We also represent the sole incorporator of University of Fort Lauderdale, Inc., a separate Florida nonprofit corporation formed by filing articles of incorporation with your office on June 4, 1999. That corporation's document number is N99000003529.

We have been asked by our clients to conduct due diligence in connection with the formation and proposed operations of these separate It appears that the formation of University of Fort corporations. Lauderdale, Inc. is improvident. Our clients' objective was to amend the articles of incorporation of Plantation Christian University, Inc., changing the name of that corporation to the "University of Fort Lauderdale, Inc." Accordingly, it is unnecessary to continue with two corporations, and with this transmittal and the enclosed documentation we are attempting to carry out our clients' goal - to operate a school under the name "University of Fort Lauderdale." Because the University of Fort Lauderdale, Inc. has not commenced to conduct its affairs, has no unpaid debts, and has not elected directors, we are able to effect the dissolution of this corporation by virtue of action by the sole incorporator. Accordingly, you will find enclosed Articles of Dissolution for the University of Fort Lauderdale, Inc., filed pursuant to Section 617.1401, Florida Not For Profit Corporation Act.

We also enclose proposed Articles of Amendment to Articles of Incorporation of Plantation Christian University, Inc., amending Article I, Article III, and Article IV of the original articles of incorporation of that corporation to reflect a change of name from "Plantation Christian University, Inc." to "University of Fort Lauderdale, Inc.", and other various revisions required for the school's pending accreditation. There are no additional amendments. Because there are no members entitled to vote on this amendment, the amendment was adopted by the Board of Directors of Plantation Christian University on the 12th day of October, 1999. We understand the filing fees for articles of amendment and articles of dissolution are \$35 each and, accordingly, we enclose this law firm's check in the amount of \$70, payable to the "Department of State", to cover the cost of filing and processing the enclosed documentation.

We assume that because we represent both of the corporations involved in this matter, and since University of Fort Lauderdale, Inc. is being dissolved, Plantation Christian University, Inc. will be permitted to amend its articles of incorporation, and change its name to "University of Fort Lauderdale, Inc." without the requirement of any specific written permission from any existing party or entity.
