ARTICLES OF INCORPORATION

OF

EACH ONE REACH ONE, INC.

A Florida Not-For-Profit Corporation



We, the undersigned, with other persons being desirous of forming a Florida not-forprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I.

The name of this corporation is:

EACH ONE REACH ONE, INC.

ARTICLE II.

The principal place of business of this corporation shall be 1252 S. Washington Avenue, Apopka, Florida 32703.

ARTICLE III.

The mailing address of this corporation shall be P.O. Box 2121, Apopka, Florida 32704.

ARTICLE IV.

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida is to provide shelter, education and job placement for young homeless women and to make charitable contributions. The purpose for which the corporation is organized are exclusively charitable and educational within the meaning of section 501(e)(3) of the Internal

Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these Articles of Incorporation, this corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE V.

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction, of the county in which the principal office of the corporation is then located, exclusively for such purposes.

ARTICLE VI.

The membership of this corporation shall constitute all persons hereinafter named as officers and directors and such other persons who from time to time may become members by a majority vote and according to the bylaws.

ARTICLE VII.
