**ARTICLES OF INCORPORATION  
OF  
FIRE SAFETY EDUCATION ASSOCIATION, INC.**

By these Articles of Incorporation, the undersigned Subscriber forms a corporation not for profit in accordance with Chapter 617, Florida Statutes, and pursuant to the following provisions ("these Articles"):

**ARTICLE I  
NAME**

The name of the corporation shall be: FIRE SAFETY EDUCATION ASSOCIATION, INC.

**ARTICLE II  
PRINCIPAL OFFICE**

The principal office of the Association is located at 3000 N. Atlantic Avenue, Suite 101 Cocoa Beach, FL 32931.

**ARTICLE III  
PURPOSE AND POWERS OF THE ASSOCIATION**

The Association is formed to provide, among other things, fire safety educational services to the public. The Association shall not pay dividends and no part of any income of the Association shall be distributed to its members, directors or officers. The Association shall have all the powers of a non-profit corporation organized under the laws of the State of Florida.

**ARTICLE IV  
BOARD OF DIRECTORS**

The affairs of the Association shall be managed by a Board of three (3) directors initially who shall be elected in the manner provided in the Bylaws of the Corporation. The number of directors may be increased or decreased from time to time as provided in the Bylaws, but at no time shall the number of directors be less than one (1). The names and addresses of persons who are to act in the capacity of director until appointment or election of their successors are:

ARTICLE V  
REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation in the state of Florida is 3000 N. Atlantic Avenue, Suite 101 Cocoa Beach, FL 32931. The name of the initial registered agent of the corporation at such address is Harvey Sackett.

ARTICLE VI  
INCORPORATOR

ARTICLE VII  
DURATION

The Association shall exist perpetually unless and until dissolved according to law. Corporate existence of the Association shall commence upon the filing of these Articles with the Florida Department of State.

ARTICLE VIII  
OFFICERS

The affairs of the Association shall be administered by the officers designated in the Bylaws. The officers shall be elected by the Board of Directors at the first meeting, and they shall serve at the pleasure of the Board of Directors. The names and addresses of the officers who shall serve until their successors are designated by the Board of Directors are as follows:

## ARTICLE IX INDEMNIFICATION

9.1 Indemnification. Every director and every officer of the Association shall be indemnified by the Association against all expenses and liabilities, including counsel fees, reasonably incurred by or imposed upon him in connection with any proceeding whether civil, criminal, administrative or investigative, or any settlement of any proceeding, or any appeal from such proceeding to which he may be a party or in which he may become involved by reason of his being or having been a director or officer of the Association, or having served at the Association's request as a director or officer of any other corporation, whether or not he is a director or officer at the time such expenses are incurred, regardless of by whom the proceeding was brought, except in relation to matters as to which any such director or officer shall be adjudged liable for gross negligence or willful misconduct, provided that in the event of a settlement, the indemnification shall apply only when the Board of Directors of the Association approves such settlement and reimbursement as being for the best interest of the Association. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such director or officer may be entitled.

9.2 Insurance. The Association shall have the power to purchase at its expense and maintain insurance on behalf of any person who is or was a director or officer of the Association, or is or was serving at the request of the Association as a director or officer of another association, against any liability asserted against him and incurred by him in any such capacity, or arising out of his status as such, whether or not the Association would have the power to indemnify him against such liability under the provisions of these Articles.

## ARTICLE X BYLAWS

The Bylaws of the Association shall be adopted by the Board of Directors and may be altered, amended or rescinded in the manner provided therein.

## ARTICLE XI AMENDMENTS

Amendments to these Articles of Incorporation shall be made in the manner provided by applicable law.


## ARTICLE XII NON-STOCK CORPORATION

The Association is organized on a non-stock basis and shall not issue shares of stock evidencing membership in the Association.

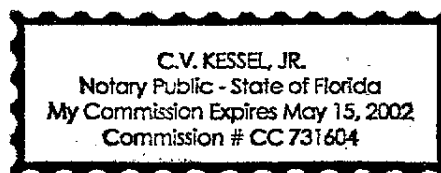
