**FIRST:** Amendment adopted: Article I is hereby amended to read as follows:

**ARTICLE I. NAME AND MAILING ADDRESS OF THE CORPORATION**

**THIRD:** Adoption of Amendment: The amendment was adopted by the members and the board of directors. The number of votes cast for the amendment was sufficient for approval.

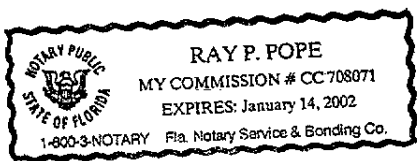
