Article VII. Purposes

Our goal is to provide a faith-based program that will help preserve the family unit.

To manage and operate a maternity house, called Miriam's House, where pregnant girls and young mothers (15-24 years of age) may find shelter for themselves and their children and learn how to cope with life's challenges more effectively.

To provide a safe home environment that will enable single teen-age mothers to complete their high school education.

To offer the girls assistance in daily life functions such as budgeting, balancing a checkbook, shopping, and providing a balanced diet.

To offer individual and group counseling and parenting classes.

To engage freely in all lawful activities and efforts including the solicitation of grants and contributions that may reasonably be intended to promote and advance the purposes stated in the Article.

Article VIII. Registered Agent and Principle Office

The Registered Agent's name and address, and the street address of the initial Principle Office of this Corporation in the State of Florida, shall be:

Karen T. Bass, 6224E. King Lane, Inverness, FL 34452. The board of directors from time to time may move the principle office to any other address within the State of Florida.

Article IX. Membership.

The membership of the corporation shall be defined in the by-laws of the corporation, as adopted by the board of directors.

Article X. Capital Stock.

The corporation does not contemplate pecuniary gain or profit, and there shall be no capital stock herein. No part of the net income of the corporation shall ever revert to the benefit of any donor, director, or officer of the corporation. This shall not prevent reasonable compensation for services they may render to the corporation.

Upon dissolution of the corporation, all of the assets then remaining shall be distributed to named recipients who must be exempt from Federal Income Tax pursuant to section 501 (c) (3) of the Internal revenue Code of 1954 as it may be amended

Article XI Board of Directors

A board of directors shall manage the business affairs of the corporation. The number of directors shall be fixed by the by-laws, and may be increased or decreased from time to time in the manned specified therein.

The initial board of directors shall consist of the six incorporates listed in Article X below. They shall serve until the organizational meeting of the corporation elects and qualifies their successors, unless they earlier resign or are removed by their peers.
