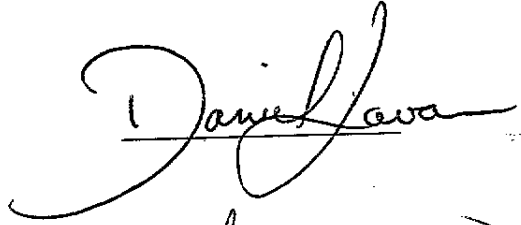

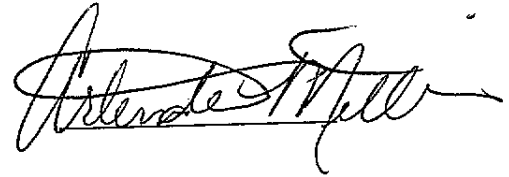

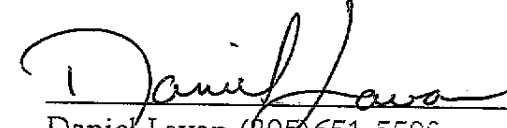

No part of the net earnings of the Corporation shall not be used for the benefit of any individual or member except as under the employment of the Corporation.

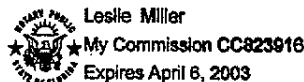

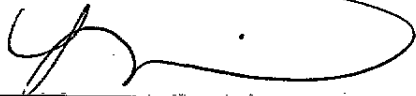
