ARTICLES OF INCORPORATION

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

ARTICLE I

Name

The name of the corporation shall be *DELTONA ARTS & HISTORICAL CENTER, INC.*

ARTICLE II

Principal Office

The place in this state where the principal office of the Corporation is to be located is the City of Deltona, Volusia County, Florida. The mailing address will be:

ARTICLE III

Purpose

Said corporation is organized exclusively for charitable, religious, education and scientific purposes, including but not limited to, exhibition of art of local artists; to act as a center for information on the birth growth, and history of the City of Deltona; and to facilitate promotion of cultural arts under section 501(c)(3) of the Internal Revenue Code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes

set forth in this article. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office, Notwithstanding any other provisions of these articles, the corporation shall not engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

#### ARTICLE IV

## ARTICLE VI

### Terms of Existence

This corporation is to exist perpetually. Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning the the Internal Revenue Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
