Incorporation stated below and files with the State Department of Florida, these Articles of Incorporation with the purpose of forming a Non Profit Foundation under the laws of the State Of Florida.

ARTICLE I

Name

Principal Office / Terms of Existence

ARTICLES III

Purpose(s)

For this purpose we will have on hand Law Firms (Attorneys) when our subscribers bring to our attention their complaints to a program that the Foundation will call "Respect Yes-Discrimination No". What this program we intends that all established laws in the United States be complied and respected. This Foundation will have programs for families or single individuals, and there the following:
 - Family Help Program
 - Family Support Program
 - Economic and / or Financial help on various family bills.
 - Family interest orientation
 - Family Health
 - Family food and clothing Program

We shall be adding more help programs not mentioned at this moment in the Article.

ARTICLE IV

Board of Directors

The names and addresses of the incorporators shall be the initial directors of the Foundation, who in subject to these articles of incorporation and the laws of the State of Florida. This initial Board will work to complete the Statues that shall govern the destination of the Foundation including the regulations. The Board of Directors is composed of the following:

- Director
- Sub-Director
- Secretary
- Finance Director
- Discipline Director

- Commissions Director
- Director of United Country to the Foundation

The proposed form of selection of the new Board of Directors is as follows: The Foundation will work with different Commissions-some shall be permanent and others transitional named by the Director in accordance of the needs.
