The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopts the following Articles of Incorporation:

Article I

The name of the corporation shall be "United Community Service, Inc."

Article II

Article III

Article V


The name and Florida street address of the initial Registered Agent are Marvin A. Cox, 2956 Jog Road, Greenacres, FL 33467.

The name and address of the Incorporator to these Articles of Incorporation are Marvin A. Cox, 2956 Jog Road, Greenacres, FL 33467.




