ARTICLES OF INCORPORATION
FOR
Christian Connection Ministries, Inc.

THE UNDERSIGNED, acting as incorporators of a corporation under the Florida General Corporation Act, adopted the following articles for such corporation:

ARTICLE I

The name of the corporation is:

Christian Connection Ministries, Inc.

The principal place of business of this corporation shall be:

6550 Royal Palm Blvd., A-109
Margate, FL 33063-2141

ARTICLE II

The period of its duration is perpetual, unless dissolved according to law.

ARTICLE III

The general purpose for which this corporation is organized are exclusively religious, charitable, literary, or educational within the meaning of Section 501 ©(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Code. Without limiting the generality of the foregoing, Christian Connection Ministries, Inc. if organized to act as a church for the sole purpose to prologuize the Gospel of Jesus Christ in an effective and efficient manner.

This corporation shall have the power to purchase, lease or otherwise acquire property, support missionaries and missions, raise funds, and do those things necessary to prologuize the Gospel in an adequate manner.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Taxes under Section 501 ©(3) of the Internal Revenue Code of 1986 or corresponding provision of any future United States Internal Revenue Law.

ARTICLE IV

The qualification for members and the manner of their admission are set forth in the Bylaws of the Corporations. The manner in which directors shall be appointed or elected will be determined in the bylaws.

ARTICLE V


ARTICLE VIII


