**ARTICLES OF INCORPORATION  
OF  
THE CENTER OF HOPE MINISTRIES, INC.,**

**ONE:** The name and address of this principal corporation is The Center of Hope Ministries, Inc., 1500 N. Congress Ave., C-23, West Palm Beach, Florida 33401. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

**TWO:** This corporation is a non-profit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Non-profit Public Benefit Corporation Law for Religious purposes. To establish structured support service for Evangelistic, Economic Development and other Ministries to support the outreach ministries for the body of Jesus Christ(The Church). In accordance with the Doctrine of the corporation creed/by-laws as a pastor to spread the gospel of Jesus Christ. The religious program will consist of Economic Development Programs, but, shall not be limited to: Homelessness, Health Care, Child Care, Youth At Risk, Tutorial, Land Acquisition, Housing, Job Training, Counseling, Employment and other programs to aid those in need.

**THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.



Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organized and operated exclusively for such purposes.
