

ARTICLES OF INCORPORATION
KIDS-AT-RISK PETS-AT-RISK INC.

ARTICLE I

The name of this corporation shall be Kids-at-Risk Pets-at-Risk, Inc. This corporation shall be a not for profit corporation formed under the laws of the State of Florida.

ARTICLE II

The address of the principal office of the corporation shall be 5770 Miller Drive, Miami, Florida 33155.

ARTICLE III

The purposes of the corporation shall be to establish a program for delinquent youths who are under the supervision of the Dade County Juvenile Court which will teach these youths how to care for and find homes for abandoned or homeless animals and to train these youths for employment as veterinarian assistants.

ARTICLE IV

The manner by which Directors shall be elected shall be specified in the corporate bylaws.

ARTICLE V

The name of the initial registered agent of the corporation shall be Thomas K. Petersen and the address of the registered office shall be 5770 Miller Drive, Miami, Florida 33155.

ARTICLE VII


The manner of selection of members and the terms and rights of membership shall be specified in the corporate bylaws. Membership shall not be transferable.
