**ARTICLES OF INCORPORATION**  
**FOR**  
**FLORIDA PERSONAL WATERCRAFT ASSOCIATION, INCORPORATED**

By these Articles of Incorporation, the undersigned incorporator forms a not-for-profit corporation in accordance with Chapter 617, Florida Statutes. Florida Not-for-Profit Corporation Act and pursuant to the following provisions

**ARTICLE I**

The name of this corporation shall be Florida Personal Watercraft Association Incorporated. The principal place of business of this corporation shall be 2061 N.W. 27<sup>th</sup> Avenue, Miami, Florida 33142.

**ARTICLE II**

The period of the duration of this corporation is perpetual unless dissolved according to law.

**ARTICLE III**

The purpose for which the corporation is organized is for all lawful purposes, including but not limited to, providing a forum for persons involved in the manufacture, sales, rental, maintenance, use and repair of personal watercraft where they can meet and exchange ideas and professional experiences and coordinating educational and professional safety programs and seminars dedicated to improving the personal watercraft industry. The corporation may buy, acquire, purchase, own, manage, sell, convey, transfer, assign, pledge, mortgage, lease and encumber real and personal property of any nature or kind.

**ARTICLE IV**

The principal office and mailing address of this corporation is located at 2061 N.W. 27<sup>th</sup> Avenue, Miami, Florida 33142.

**ARTICLE V**

The qualifications for members and the manner of their admission shall be as provided for in the Bylaws of the corporation.

The initial Board shall be comprised of three (3) directors, but may be enlarged to as many as five (5) members by amendment to the Bylaws of the corporation. ## **ARTICLE VIII**

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organization described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986, as amended, or corresponding sections of any prior or future law, or the Federal, State, or Local Government for exclusive public purposes.

## **ARTICLE IX**

## **ARTICLE X**

The street address of the initial office of the registered agent of the corporation in the State of Florida shall be Robinson & Associates, P.A., 1501 Venera Avenue, Suite 300, Coral Gables, Florida 33146. The name of the initial registered agent of the corporation at the registered office shall be Raymond L. Robinson, Esq..

## **ARTICLE XI**

The Bylaws of the corporation shall be adopted by the Board of Directors and may be altered, amended or rescinded in the manner provided by the Bylaws.

## **ARTICLE XII**

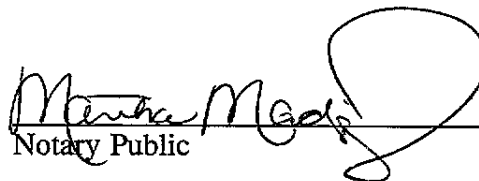
These Articles of Incorporation may be amended in the manner provided by law.

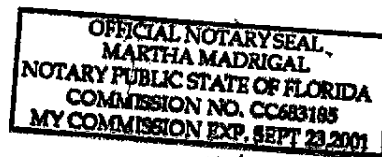
