ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

HEARTS FOR THE HARVEST, INC.

ARTICLE II PRINCIPLE OFFICE

The principle place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSES

The specific purposes for which this corporation are:

To preach the good news of Jesus Christ in the United States and to many nations of the world.
To demonstrate that good news by providing food, clothing, medical supplies and literature distribution in the countries where such ministry is needed.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors shall be appointed is:

All directors and officers are appointed for a term of one year at a time and can be extended on a yearly basis, if so is necessary. They shall be selected from trustworthy Christian people who demonstrate values and vision similar to those of this ministry.

The President shall be responsible for the day to day operations of the ministry.

The Vice President shall assist the President in the day to day operation of the ministry and other duties as required or assigned.

The Secretary/Treasurer shall maintain all records and oversee the handling of all funds and the disbursement thereof.

The Board of Directors shall consist of no less than three other individuals who have a common vision for ministry. They shall assist the ministry in an advisory capacity.
