ARTICLES OF INCORPORATION

In compliance with chapter 617, F.S., (Nonprofit)

ARTICLE I - NAME

The name of the corporation shall be:

ARTICLE III - PURPOSE

The purpose for which the incorporation is organized is:

The primary purposes of this organization are exclusively charitable, medical and educational. The specific purposes are to increase access to medical and educational services in communities through volunteer effort; to provide these services in order to enhance the level of healthcare in the Caribbean and in our local community; to blend both the professional and student volunteer workers and augment these services to those in need; to provide services that will benefit not just the Caribbean but those in our local community who are in need of medical, educational and other assistance as well; to obtain needed medication, medical supplies and equipment and distribute to outreach clinics; to provide a means of offering assistance to the Caribbean and our local community through these and other services and charitable donations.

ARTICLE IV - MANNER OF ELECTION

The incorporators, named in the articles of incorporation, shall serve as initial directors and elect the beginning directors. Directors shall be elected by the affirmative vote of a majority of the directors present at the duly held meeting of the board, except that no director shall vote for his or her own election, and shall serve for a term of three years each. Elections will be held annually where each director is elected by a majority vote of the directors.




