Amendment to Articles of Incorporation (A Corporation Not-For-Profit)

The following provisions for the Articles of Incorporation of the Community Development, Economic Revitalization, and Social Services Programs of Hialeah-Seminola, Incorporation a Florida Not-For-Profit Corporation, filed with the Department of State in Tallahassee, Florida, on June 21, 1999, are hereby amended as follows:

<u>Article Three: Purposes</u> <u>Section 1. General Purposes:</u>

The purposes of the Corporation are educational and charitable within the meaning of Section 501 (c) (3) of the United States Internal Revenue Code of 1986, as amended. Without limiting the generality of such purposes, the Corporation intends:

- 1. To promote the development of adequate low-cost housing to meet the needs of the poor and low-income residents of South Florida;
- To engage in the organization of non-profit housing development with residents' homeownership and to engage in the creation of rental housing for low to moderate income persons;
- To provide mentors to children needing assistance in their growth and well-being;
- 4. To provide tutorial services for children in need that will aid children with enhanced educational opportunities;
- To provide services to the elderly needing assistance with health, safety, and well-being;
- 6. To provide liaison services between the elderly and existing social services programs;
- To provide volunteers that will fulfill everyday tasks for the elderly in need.
