ARTICLES OF INCORPORATION

of

IGLESIA PUERTA DE SION INCORPORATED  
SION'S DOOR CHURCH INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida, applicable to corporations not for profit under the following proposed charter:

ARTICLE I

NAME

The name of the corporation shall be IGLESIA PUERTA DE SION INC.  
SION'S DOOR CHURCH INC.

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 1745 N.W. 15 St. Rd. Miami, FL. 33125

ARTICLE III

OBJECT

The general nature of the object of the corporation shall be to acquire or build, equip, maintain own and provide for the operation of a church institution and related facilities in connection therewith to acquire and administer funds and property which, after the payment of necessary expenses, shall be devoted exclusively to the cause of charity, education and religion without making a profit therefrom, and to solicit and accept gifts of money or property, real or personal, in order to carry out the aforementioned purposes.

#### ARTICLE IV

##### MANNER OF ELECTION OF DIRECTORS

This corporation shall consist of no less than four members that shall be elected by a majority vote of a membership committee to be hereinafter established by the trustees hereof

The Trustees shall make reports of their receipts, disbursements and balances and the affairs of the Corporation to annual sessions of said Corporation and when requested shall make special reports to the membership.

BY LAWS

ARTICLE XI

It shall be required to provide a thirty day prior notice to the membership of the presentation of such amendment.

ARTICLE XII

DISPOSITION OF ASSETS UPON DISSOLUTION

Upon dissolution of this Corporation and of its assets

remaining after payment of all costs and expenses of said dissolution shall be distributed to an organization that does qualify under Section 501 (c) (3) of the Internal Revenue Code. To be qualified to receive such assets the above organization must be qualified under Section of the Internal Revenue Code, or of the Federal Government or of the State, or local government for public purposes, and none of the assets will be distributed to any particular officer or trustee of this organization.

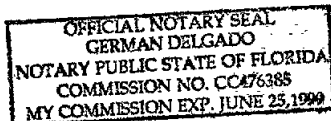
