

## AMENDING OR ADDING ADDITIONAL ARTICLES

### ARTICLE 1

The name of this corporation is INTERNATIONAL MISSIONARY CHURCH OF GOD, INC.

### ARTICLE II

#### Specific and General Purposes

- A. The specific and primary purpose for which this corporation is founded is to establish and maintain a Headquarter for **International Missionary church of God, Inc.**, cooperating with the international missionary program of the church, and to provide places of public worship in the area of Palm Beach County, State of Florida, where the General Headquarter is established, and to implement leadership training within the meaning of Section 501 (c) 3 of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law and Chapter 617 of Florida Statutes. In furtherance of such purposes, the Organization shall have the power to:
- (a) To establish, maintain and conduct theological schools for the instruction of religious leaders, candidate for future ordain, commission, or license ministers, national and international missionaries, mission stations, the young ministers and to further other religious, educational and charitable work to that end, adopt and establish by-laws and make all rules and regulations deemed necessary and expedient for the management of its affairs in accordance with the law and not inconsistent with these Articles of Incorporation;
  - (b) To create an environment for the national and international children learning; to promote the use of different and innovative learning methods; to provide opportunities for all children to maximize and expand their learning experiences as well as identify and address any deficiencies; to promote the use of different and innovative learning methods; to enhance the children motivation by increasing self-esteem; to provide standards of behavior and accountability; to provide a safe environment where the children feel free to express their religious beliefs; to require the measurement of learning outcomes and skill mastery of the basic reading, writing, mathematics, science and the arts and to create an environment where the instructors can use new methods to address all the needs of the children in order to promote learning.
  - (c) To acquire, buy, hold, own, sell, exchange, convey, lease, or otherwise dispose of goods, chattels, effects and merchandise; To mortgage, lease, hypothecate, convey, exchange, and dispose of lands and chattels, to acquire, by gift, annuity, bequest, or otherwise, property, both real and personal, or otherwise, and to promote the diffusion of religious literature and education loyal to the New Testament faith as held by this church; To do anything pertinent to the above.

**B.** In accordance with the principles of the New Testament, International Missionary Church of God, Inc. recognizes that we exist for the purpose of furthering the kingdom of God through worship, evangelism, discipleship, missions, and fellowship. Therefore, the planning process for every event should begin with the question, "How will this event further the kingdom of God?"

- (a) **Worship.** We understand from Revelation 4:10-11 that we were created to worship God. International Missionary Church of God, Inc. will encourage both corporate and individual worship in the Spirit. In other words, we desire our corporate worship to be Spirit-led rather than pulpit-driven.
- (b) **Evangelism.** We understand from Matthew 28:19-20 that the Lord commanded that the Gospel be carried to the whole world. International Missionary Church of God, Inc. will evangelize our community through church sponsored events and personal evangelism. We will also support the efforts of our national and international mission departments through prayer, finances, and giving of ourselves.
- (c) **Discipleship.** We understand from Colossians 1:28 and Ephesians 4:13 that each believer is to be conformed to the image of Christ. International Missionary Church of God will assist each believer in moving toward maturity in Christ by providing sound biblical instruction, promoting the practice of the spiritual disciplines such as prayer, fasting, and daily devotions, and by helping each one discover his/her spiritual gifts.
- (d) **Mission.** We understand from the biblical perspective of Matthew 28:18-20 that we are recommended to reach the whole world by announcing Jesus Christ to the lost, bring them to have faith in Jesus Christ, baptizing the believers and planting new local churches. International Missionary Church of God, Inc. will help each member to embrace the world mission and to encourage them to support the program of the church by supporting with their prayer and finances.
- (e) **Fellowship.** We understand from Acts 2:42 that Christian fellowship is vitally important to the Body of Christ. By definition, the purpose of Christian fellowship is to edify, exhort, and comfort one another. International Missionary Church of God will encourage Christian fellowship through gatherings of all types, whether they will be large, small, public, private, formal or informal.

**C.** The activities of the Organization will be financed by the tithing, offerings and the contributions of the members, other charitable organizations; No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision

of this document, the organization shall not carry on any other activities not permitted to be carried on ( a ) by an organization exempt from federal income tax under section 501( c ) ( 3 ) of the Internal Revenue Code, or corresponding section of any future federal tax code, or ( b ) by an organization, contributions to which are deductible under section 170 ( c ) ( 2 ) of the Internal Revenue Code, or corresponding section of any future federal tax code.
