#### ARTICLES OF INCORPORATION

## BY FAITH RESTORATION MINISTRIES, INC. A Non-Profit Corporation

To further common purposes, the undersigned persons agree to organize under these Articles of Incorporation.

#### ARTICLE I

#### NAME

The name of this corporation shall be **BY FAITH RESTORATION MINISTRIES**, **INC.**, a **Non-Profit Corporation**; Located at 310 W. Bay Dr., Largo, FL 33746 as its principal office and place of business (ministry). **Mailing address:** P.O.Box 481, Largo, FL 33746.

#### ARTICLE II

#### ENABLING LAW

This corporation is organized pursuant to the Corporations Not For Profit Law of the State of Florida, set forth in Part One of Chapter 617 of the Florida Statues.

#### ARTICLE III

#### **PURPOSES**

This Corporation is organized as a church and shall be operated exclusively for charitable and educational purposes by teaching, preaching, publishing, proclaiming, distributing, disseminating and declaring by oral, written, or other means the Christian Gospel, the study of the Sacred Scriptures (Bible), and the worship of the Lord Jesus Christ.

This corporation is organized and operated exclusively for non-profit purposes, and no part of any net earnings shall inure to the benefit of any member, director, or officer

This corporation shall have and exercise all rights and powers conferred upon corporations under the laws of the State of Florida, provided however that this corporation is not empowered to engage in any activity that in itself is not in furtherance of its purposes.



#### ARTICLE IV

#### **TERM**

This corporation shall have a perpetual existence.

#### ARTICLE V

#### **MEMBERSHIP**

The membership and directors (officers) of the corporation shall consist of all natural persons elected to membership in such manner as the By-Laws may provide.

#### ARTICLE VI

#### MANAGEMENT OF CORPORATE AFFAIRS

(a) **BOARD OF DIRECTORS (TRUSTEES)**. The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of not less than three Directors (Trustees). The number of Directors and election of Directors herein provided for may be changed by a By-Law duly adopted by the members entitled to vote. Directors shall be elected or appointed in the manner and for the terms provided in the By-Laws.
