**ARTICLES OF INCORPORATION**

**ARTICLE I:**

The name of the corporation shall be:

Pure Energy Dance Parent Teacher Organization, Inc.

**ARTICLE II:**

The principal place of business and the mailing address of this corporation shall be:

300 Business Parkway, Suite A  
Royal Palm Beach, Florida

**ARTICLE III:**

**Purpose(s)**

The specific purpose(s) for which the corporation is organized are:

To be a charitable, not-for-profit, corporation and to promote through educational programs, which are directed toward parents and students, which are developed through committees, projects, and programs.

**ARTICLE IV**

The manner in which the directors are elected or appointed is as follows:

Section 1: Each officer of this organization shall be a member of Pure Energy Dance Company PTO, Inc.

Section 2: Officers and their election: -

- a. The officers of this organization shall consist of a president, two (2) vice presidents, secretary, and a treasurer.
- b. Officers shall be elected by ballot annually in the month of July by members of the organization. However, if there is but one nominee for any office, election for that office may be by voice vote.
- c. With the exception of the Treasurer, officers shall assume their official duties at the close of the meeting in July and shall serve for a term of one year or until their successors are elected. The Treasurer shall assume his duties after the books have been audited.
- d. A person shall not be eligible to serve more than two consecutive terms in the same office, unless, majority of those present and eligible to vote, waive this provision.
- e. The manner in which the directors are elected is as stated in the By-Laws.

**ARTICLE V:**

**Limitation of corporate powers**

The corporate powers of this corporation are as provided in section 617.00302, Florida Statutes.
