ARTICLES OF INCORPORATION SECRETARY OF STATE
TALLAHASSEE, FLORIDA

SAVE OUR MANATEE LANDS, INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be Save Our Manatee Lands, Inc.

ARTICLE II

Principal place of business and mailing address

The street address of the initial principal office of the corporation shall be 1408 99th Street N.W., Bradenton, Florida 34209.

ARTICLE III

Purpose(s)

The specific purposes for which the corporation is organized are to represent the interests of the property owners and residents in the area of Manatee County, Florida, known as Northwest Bradenton, in matters relating to zoning, land use, the environment, health, safety, public utilities and services and other matters, by liaison with governmental and other agencies and by other appropriate means, and to promote continuing improvements for the mutual benefit of the members.

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows: Initially, the directors shall be appointed by the incorporator and subsequently, beginning at the 2000 annual meeting, the directors shall be elected by plurality vote of the members of the corporation.

ARTICLE V

Corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes.

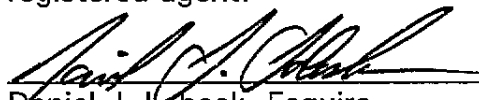
