#### ARTICLES OF INCORPORATION TALLAHASSEE, FLORIDA

#### SAVE OUR MANATEE LANDS, INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

#### ARTICLE I Name

The name of the corporation shall be Save Our Manatee Lands, Inc.

## ARTICLE II Principal place of business and mailing address
