

Amended to the article of corporation

No part of the net earnings of the organization shall insure to the benefit of, or be distributed to, its members, trustees, officers or private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes forth in the purpose clause hereof. No substantial part of the activities the organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall nor participate in, or intervene in (including the publishing or distribution of statements) any political campaing on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any others activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, section 170 (c) (2) of the ~~Int~~ Internal Revenue Code, corresponding section of any future federal tax code.
