

**AMENDMENT TO THE ED
ARTICLES OF INCORPORATION
OF 13 MAY 20 PM 3:14
GREAT COMMISSION FOUNDATION, INC.
TALLAHASSEE, FLORIDA**

Pursuant to the provisions of Section 607.01, Florida Statutes, Great Commission Foundation, Inc. (the "Corporation") adopts the following amendments to its Articles of Incorporation:


1. Article VII is deleted in its entirety and the following is substituted in lieu thereof:

"ARTICLE VII

Directors

The affairs and property of this corporation shall be managed and governed by a Board of Directors, composed of seven (7) individuals. The Directors of the corporation including the Chairman, shall be nominated by the district nominating committee of the Central Florida District Church of the Nazarene, Inc., and elected by a majority vote of the district assembly of the Central Florida District Church of the Nazarene, Inc. by ballot at the annual district assembly meeting, and shall include the District Superintendent as a member of the Board."

The undersigned hereby executes this Amendment to the Articles of Incorporation of Great Commission Foundation, Inc., as adopted by the Board of Directors of Great Commission Foundation, Inc. on March 12, 2013. There are no members entitled to vote on this Amendment.
