**ARTICLES OF INCORPORATION**

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the corporation is **Central Florida Family Sportsman's Association, Inc.**

**ARTICLE II: PRINCIPAL OFFICE**

The principal place of business and mailing address of the corporation is **500 South 14th Street, Haines City, FL 33844.**

**ARTICLE III: PURPOSE**

The purpose of the corporation is to be a sportsman's club.

**ARTICLE IV: QUALIFICATION**

The qualifications for members and the manner of their admission are stated in the bylaws of the corporation.

## **ARTICLE X: AMENDMENTS**


The corporation reserves the right to amend or repeal any provisions of these Articles of Incorporation, or any amendment(s) thereto.
